**Inflatable Rental Agreement**

**1. EQUIPMENT, RENT AND TERMS OF RENTAL AGREEMENT:** The Undersigned, as Lessee, hires from SEGA BOUNCE, LLC as Lessor, the SEGA BOUNCE unit/units, listed above and \_\_\_\_\_ blower/s. The Rental Fee as stated above is payable in advance from the time of commencement, Start Time to End Time.

**2. DELIVERY:** To the street address specified above by Lessee (customer). Lessee grants Lessor (SEGA BOUNCE) right to enter the property at the said street address (Delivery Address) for the delivery and subsequent pick up of the SEGA BOUNCE unit at the specified time.

**3. TRANSPORTATION EXPENSE:** Except as provided herein, all charges in delivering and subsequent pick up of the SEGA BOUNCE unit with respect to the Delivery Address are included in the Rental Fee noted above.

**4. GENERAL RULES TO FOLLOW DURING USE OF THE SEGA BOUNCE UNIT:**

a. Only compatible age groups and size shall play on the SEGA BOUNCE unit at the same time. The Maximum number of riders of each group that should play in the SEGA BOUNCE unit at one time are:

<u>Unit Size</u>	<u>Children 8</u> & under	<u>Children 9</u> to 12	<u>Older Teens</u>	<u>Adults</u>

b. All riders **MUST REMOVE SHOES, EYE GLASSES AND ANY SHARP OBJECTS FROM THEIR CLOTHING** before playing in the SEGA BOUNCE unit.

c. To avoid neck and back injuries, FLIPS ARE NOT ALLOWED.

d. CHILDREN'S SAFETY DEPENDS UPON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE SEGA BOUNCE UNIT, THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY.

e. Absolutely no "Silly String", gum, candy, food or other sticky substances are allowed in the SEGA BOUNCE unit. If upon pickup, such cleaning is required then a \$50.00-100.00 cleaning fee shall be automatically imposed.

f. **DO NOT MOVE** the SEGA BOUNCE unit from the place where it was installed, this may cause damage to the unit. Rental units that are set up on hard surfaces such as concrete or asphalt must be closely watched to prevent their moving. If the SEGA BOUNCE unit moves, pull the corner back to its original location of installation. If the equipment moves off the provided tarp, damage or staining may occur on the bottom of the unit. **CAUTION:** Keep the SEGA BOUNCE unit away from swimming pools.

**5. SPECIAL INSTRUCTIONS:** The SEGA BOUNCE unit's equipment is reliable. Should the unit begin to deflate: (1) The motor may have stopped, in which case, check the cord connection at the outlet near the motor, and remember to keep only 100 foot extension cord on the outlet (stronger outlets are in the kitchen and laundry room). (2) If the motor is continuing to run, check the air intake on the side of the motor for blockage, and check both tubes at the back of the SEGA BOUNCE unit for snugness; re-tie if necessary. (3) If you cannot correct the problem call SEGA BOUNCE at (901) 409-3159.

**6. SAFE OPERATION ACKNOWLEDGMENT:** LESSEE ACKNOWLEDGES THAT HE/SHE HAS BEEN INSTRUCTED ABOUT AND FULLY UNDERSTANDS THE SAFE OPERATION OF THE SEGA BOUNCE UNIT THAT IS THE SUBJECT OF THIS RENTAL AGREEMENT. LESSEE AGREES TO OBSERVE ALL SAFETY PRECAUTIONS. LESSEE ALSO REPRESENTS AND WARRANTS THE SAFE RETURN OF THE UNIT AND HEREBY AGREES TO PAY FOR THE REPLACEMENT VALUE (\$1200-\$8,000-DEPENDING ON UNIT MODEL) OF THE UNIT IF THE UNIT IS NOT RETURNED.

**7. MAINTENANCE:** Lessee agrees to keep the SEGA BOPUNCE unit in the same condition as when received, ordinary wear excepted.

**8. ALTERATIONS AND ATTACHMENTS:** No alteration in or attachments to the SEGA BOUNCE unit will be made without prior written approval of Lessor (SEGA BOUNCE, LLC).

**9. WARRANTY:** Lessor warrants that the SEGA BOUNCE unit leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement. The SEGA BOUNCE unit is supplied and maintained subject to this warranty. Lessor's obligation under this Rental Agreement is limited to repair or replacement of the SEGA BOUNCE unit when Lessor determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranties expressed or implied, and of any and all obligations and of all liabilities on the part of the Lessor for damages, including, but not limited to, consequential damages, arising out of or in connection with the use or performance of the SEGA BOUNCE unit.

**10. TITLE TO SEGA BOUNCE, LLC:** Lessee agrees to keep the SEGA BOUNCE unit in his/her custody and not to sublease, rent, sell, remove from the Delivery Address, or otherwise transfer such SEGA BOUNCE unit. The SEGA BOUNCE unit will remain the property of the Lessor and may be removed by Lessor at any time after the termination of this Rental Agreement.

**11. RELEASE OF LIABILITY:** The Lessee shall be in charge of the SEGA BOUNCE unit's operation, and is fully responsible for its operation as well as return of the SEGA BOUNCE unit in good working order. Lessor and its officers, employees and agents is /are not responsible for injury occurring to the Lessee or to any other persons using the SEGA BOUNCE unit, and the Lessee further agrees to hold the Lessor and its officers, employees and agents free and harmless against any injury or claims. The Lessee shall indemnify the Lessor and its officers, employees and agents from /against any costs incurred due to claims from anyone and for attorney's fees and related costs involving the use and return of the SEGA BOUNCE unit, should legal action become necessary.

**12. ENTIRE AGREEMENT:** The Rental Agreement constitutes the full agreement between Lessor and Lessee. Time is of the essence in this Rental Agreement. The receipt of the SEGA BOUNCE unit that is the subject of this Rental Agreement is in good working order and repair and this is so acknowledged by Lessee.

**13. RAIN POLICY:** DURING PERIODS OF SEVERE WEATHER CONDITIONS (I.E. RAIN, HIGH WINDS, ETC.), WE RESERVE THE RIGHT TO CANCEL YOUR RESERVATIONS. IF CONDITIONS ARE NOT TOO SEVERE WE WILL GIVE YOU THE OPTION OF KEEPING IT OR NOT. IF YOU DECIDE TO KEEP THE UNIT FOR THE TERM OF THIS RENTAL AGREEMENT, THERE WILL BE NO REFUNDS!

## **Set-up and Pick-up Information**

\* Plan a spot in a flat area free from debris and away from your house and obstructions. Grassy level areas are required.

Approximately 32L X 13W X 13H for Wet/Dry Combo

Approximately 27L X 11W X 15H for Jr. Dolphin Water Slide

Approximately 32L X 15W X 18H for Big Tropical Wave

\* Bounce houses and slides need an electrical source within 50 - 100 feet

\* All unnecessary electric wires and cables should be kept away from the inflatable.

\* Keep all party candies and party toys such as silly string and other toys away from the inflatable.

\* Keep all food, drink and snacks a safe distance away from the inflatable.

\* Be sure there is enough overhead clearance from trees, wires, or any other obstructions
